HUMAN SERVICE EXPENSE THE TWO TEN MISSION IS TO BRING SHOE PEOPLE TOGETHER TO HELP EACH OTHER DURING CRISIS, SUPPORT EACH OTHER AS A COMMUNITY, AND ENSURE THE FUTURE OF THE FOOTWEAR INDUSTRY IN THE UNITED STATES IN FY16, THE TWO TEN SOCIAL SERVICES TEAM ASSISTED 1,234 FOOTWEAR FAMILIES WITH EMERGENCY ASSISTANCE TWO TEN RECEIVED CALLS FROM A TOTAL OF 2,735 FOOTWEAR WORKERS AND THEIR FAMILIES AND 99% OF THOSE WORKERS RECEIVED A CALL BACK WITHIN TWO BUSINESS DAYS TO COMPLETE OUR INTAKE PROCESS THE 30 MINUTE INTAKE CALL IS THE WAY WE DETERMINE ELIGIBILITY AND HOW BEST TO MEET IMMEDIATE NEEDS WHEN A PERSON CALLS TWO TEN, WE GUARANTEE THEY WILL QUICKLY SPEAK WITH A COMPASSIONATE INDIVIDUAL AND THEIR CONVERSATION WILL BE CONFIDENTIAL IN FY16, 72% OF CALLERS WERE FEMALE AND 28% OF CALLERS COUNSELING AND INFORMATION REFERRALS IN FY16, TWO TEN PROVIDED FUNDS TO PAY THE RENT OR MORTGAGE OF 663 FAMILIES TO PREVENT EVICTION OR FORECLOSURE WE ASSISTED 582 FAMILIES WITH EMERGENCY UTILITY SUPPORT AND CAR PAYMENTS OR CAR REPAIRS FOR 451 FAMILIES SO THEY COULD CONTINUE TO USE THEIR CAR TO GET TO WORK TWO TEN ALSO HELPED WITH 125 CRISIS CASES WHICH INCLUDES \$3,000 IN FUNERAL BILLS AND EMERGENCY COSTS WHEN AN INDIVIDUAL WAS DISPLACED DUE TO A FIRE, FLOOD AND NATURAL OR COMMUNITY DISASTER FUNDS ARE PAID DIRECTLY TO THE CREDITORS EXCEPT IN A SMALL NUMBER OF CASES WHEN MINI-GRANTS PROMISE IN FY16, TWO TEN FUNDED 310 STUDENTS WITH SCHOLARSHIPS IN COLLEGE TUITION 83% OF THE STUDENTS ARE ATTENDING TWO-YEAR AND FOUR-YEAR PUBLIC UNDERGRADUATE UNIVERSITIES AND COLLEGES ACROSS THE COUNTRY, WHILE 17% ARE ATTENDING PRIVATE SCHOOLS SCHOLARSHIP FUNDS WERE AWARDED TO 168 RENEWAL SCHOLARS AND 142 NEW SCHOLARS MOST STUDENTS RECEIVED AN AWARD BETWEEN \$2,500 AND \$5,000 WITH THE OPPORTUNITY TO RENEW ANNUALLY, PROVIDED THAT THEY MAINTAIN A REQUIRED GPA OF AT LEAST 2.5 AS OF JULY 2015, ALL NEW SCHOLARSHIP AWARDS WILL AVERAGE \$3,000 PER ANNUM, RENEWABLE FOR THREE YEARS TWO TEN ALSO PROVIDES A SCHOLARSHIP FOR MILITARY VETERANS, CALLED THE FOOTWEAR WARRIORS ENDOWED SCHOLARSHIP THIS SCHOLARSHIP IS MADE AVAILABLE TO THE MEN AND WOMEN WHO HAVE SERVED OUR U S MILITARY AND ARE CURRENTLY WORKING IN THE FOOTWEAR INDUSTRY WITH THE COST OF HIGHER EDUCATION SOARING, TWO TEN SCHOLARSHIPS HELP EASE THE BURDEN FOR THOSE FOOTWEAR FAMILIES SENDING THEIR CHILDREN TO COLLEGE TO BE ELIGIBLE TO APPLY AND BE CONSIDERED FOR A TWO TEN SCHOLARSHIP, THE APPLICANT MUST BE WORKING WITHIN THE FOOTWEAR INDUSTRY FOR A MINIMUM OF TWO YEARS, OR THE CHILD OF A PARENT WORKING IN THE INDUSTRY FOOTWEAR DESIGN APPLICANTS FOR THE FOOTWEAR DESIGN SCHOLARSHIP ARE REQUIRED TO SUBMIT THREE SAMPLES OF THEIR SKETCHES AT THE TIME OF APPLICATION IN ADDITIONAL TO COMPLETING OUR STANDARD ONLINE APPLICATION THE APPLICATION ADMINISTRATION PROCESS IS OUTSOURCED TO THE INTERNATIONAL SCHOLARSHIP AND TUITION SERVICES (ISTS) AFTER ISTS PRESENTS THE COMPLETED APPLICATIONS, TWO TEN SCHOLARSHIP STAFF
